THE CHALLENGE

SEVERE CASH FLOW PROBLEMS

South Dakota critical access hospital, Bennett County Hospital and Nursing Home, was experiencing severe cash flow problems that threatened their future survival. These problems stemmed from a number of economic issues — decreasing Medicaid reimbursement rates, the downward spiral of a recession, rising healthcare costs and lack of coverage from Indian Health Services.

THE SOLUTION

INTERIM CONTROLLERSHIP SERVICES

Casey Peterson, Ltd. had worked with the rural hospital located in Martin, South Dakota as its audit and cost report provider for numerous years. During the course of this work and other consulting tasks, Casey Peterson, Ltd. was able to identify a number of opportunities to turn the hospital's financial position around. Unfortunately, the level of service necessary to capitalize on those opportunities would prohibit the firm from providing audit services under accounting professional standards. Accordingly, the firm assisted the hospital in engaging a new auditor and Casey Peterson, Ltd. began providing monthly controllership services.

One such example of the benefit of this arrangement came when Casey Peterson, Ltd. became involved in communications with the State of South Dakota to provide the state with accurate information on the hospital. This disclosure led to an increase of the hospital's nursing home rates, producing approximately \$204,000 in additional cash flow over a six-month period. Upon reviewing of current hospital Medicaid rates, Casey Peterson, Ltd. discovered that the hospital would receive an immediate cash settlement from the state Medicaid program if cost report settlements were accelerated. The final settlement occurred six months earlier than expected. This process generated an immediate \$234,000 in cash flow for the hospital. This significantly increased the hospital's inpatient and outpatient Medicaid rates which generated an additional \$90,000 in cash flow over the next 12 months. Casey Peterson, Ltd. also amended prior year cost reports which resulted in the hospital receiving an additional \$175,000 and we identified \$25,000 more in reimbursement stemming from bad debts that were not submitted on prior year cost reports.

Casey Peterson, Ltd.'s role as interim controller has helped to improve the hospital's financial information, as well as put the firm in contact with the hospital's management team and Board of Directors. This arrangement allowed management to make more informed decisions. Casey Peterson, Ltd. continues to be involved on a monthly basis in the training and educating of hospital employees. The hospital continues to thrive and has recently implemented electronic medical records and expanded its ancillary services.

THE RESULTS

In a four-month period, Casey Peterson, Ltd. assisted Bennett County Hospital in **increasing its cash flow by \$728,000**, while at the same time providing valuable information, training and education to help secure the hospital's long-term success.
