WHAT IS PAYROLL-BASED JOURNAL?

Centers for Medicare & Medicaid Services — or CMS — view staffing as a vital component of a nursing home's ability to provide quality care.

Under the Affordable Care Act, CMS developed Payroll-Based Journal — or PBJ. PBJ is the federally required electronic system that allows facilities to submit staffing data.

Through PBJ, CMS can determine staffing at a highly detailed level and monitor employee turnover rates more frequently and quickly.

HOW DOES PBJ INFORMATION GET USED?

CMS posts staffing information on its Nursing Home Compare website and uses the data for its Nursing Home Five Star Quality Rating System. The information can help consumers choose the right facility for their loved ones.

Depending on the information a facility provides, the CMS may also require state Departments of Health to perform Sunday audits to check a nursing home's staffing levels.

There have also been recent cases where PBJ and nursing home staffing levels have come into play in lawsuits throughout the country.
